#### **July 14**

#### **Conference Call for All Participants**

#### **July 14 – July 20**

**Module 1:** An Introduction to Economic and Social (ES) Rights and their Implementation in Canada.

**Featured Expert:** Leilani Farha, [UN Special Rapporteur on the Right to Housing](#) and Executive Director of Canada Without Poverty.

Participants will be provided with an overview of international human rights law as it pertains to economic and social rights in Canada. This will include how Canada has been assessed by the United Nations in terms of its human rights performance. There will also be a discussion of the legal framework of economic and social rights, with a particular focus on the role of the United Nations.

#### **July 18**

#### **Remote Presentation and Conference Call for All Participants**

In this remote presentation, participants will be able to view a presentation from their home computers. With an accompanying oral presentation over the telephone, the moderator will walk participants through Canada’s particular obligations including the role of particular international human rights covenants and mechanisms by which to access economic and social rights.

**Module 2: Applying International Human Rights at all levels of government (Case Study on British Columbia)**

In the second module, participants will be provided with an overview of international human rights standards and their implementation for poverty at all levels of government (federal, provincial/territorial and local). Readings will focus on how ES rights can be implemented or have been implemented in Canada (e.g.: through courts and other adjudicative bodies, political avenues, and policies and programs). Examples will be provided of advocacy efforts being undertaken to advance an anti-poverty agenda at all levels of government.

Despite having one of the highest rates of poverty in Canada for the past thirteen years, British Columbia is the only province or territory in Canada with no announced intention of creating a provincial poverty reduction strategy. In this one hour conference call, the moderator will lead anti-poverty advocates Seth Klein and DJ Larkin through the application of international human rights in the unique context of BC.
